Guiding Questions

Please use these questions as inspiration while writing your letter. You may focus on the questions most relevant to your work. Your application will be scored based on your response to these questions.

Being a Good Relative

How does your organization or project reflect Indigenous values of relationship, reciprocity, and responsibility? What does it mean to be a good relative in your community, and how does your work contribute to this?

Community & Impact

What is the story of your organization? What inspired its creation, and what change are you working toward? Who do you serve, and how do you ensure your work is rooted in community needs and leadership? What impact have you already made, and how would this funding allow you to deepen or expand your work?

Reciprocity & Sustainability

How do you build and maintain relationships with others doing similar or complementary work? In what ways do you practice reciprocity within your organization and community? How do you engage community feedback in your work? How will you sustain your work beyond this grant?
